About Loyola

Loyola College, a Catholic Minority Institution, was founded by the Society of Jesus (Jesuits) in 1925, with the primary objective of providing University Education in a Christian atmosphere for deserving students irrespective of caste and creed. It started functioning in July 1925 with just 75 students on the rolls in three undergraduate courses Loyola College, though affiliated to University of Madras, and became autonomous in July 1978. It is autonomous, in the sense that it is empowered to frame its own course of studies and adopt innovative methods of teaching and evaluation.

The University degrees will be conferred on the students passing the examinations conducted by the college. UGC conferred the status of "College with potential for Excellence" on Loyola College in 2004 and confirmed the same in 2010. NAAC's reaccreditation score in 2012 (Third Cycle) is 3.70 out of 4.00 CGPA. UGC has elevated Loyola College to the status of "College of Excellence" for the period from April 1, 2014 till March 31, 2019.

About the Department

Department of Commerce was established in 1945 offering B.Com, degree course and the Department of Commerce – shift II has been providing quality education since 1998. Currently there are around 1200 student for B.Com (Shift II). The department teaches the syllabi (common to Shift I & II) through learner-centered teaching methods such as case studies, role play, field visits and project work. Beside the regular program, the department offers value added Conferences, Seminars and co-curricular programs.

About DGFT

Directorate General of Foreign Trade (DGFT) organisation is an attached office of the Ministry of Commerce and Industry and is headed by Director General of Foreign Trade. Right from its inception till 1991, when liberalization in the economic policies of the Government took place, this organization has been essentially involved in the regulation and promotion of foreign trade through regulation. Keeping in line with liberalization and globalization and the overall objective of increasing of exports, DGFT has since been assigned the role of "facilitator". The shift was from prohibition and control of imports/exports to promotion and facilitation of exports/imports, keeping in view the interests of the country.

This Directorate, with headquarters at New Delhi, is responsible for formulating and implementing the Foreign Trade Policy with the main objective of promoting India's exports. The DGFT also issues scrips/authorization to exporters and monitors their corresponding obligations through a network of 38 regional offices and an extension counter at Indore. DGFT HQ and many of its regional offices are ISO 9000:2008 certified

Organizations. All regional offices provide facilitation to exporters in regard to developments in international trade, i.e. WTO agreements, Rules of Origin and antidumping issues, etc. to help exporters in their import and export decisions in an internationally dynamic environment.

About The Seminar

The seminar is to create awareness to the college students about the importance and implications of exporting to foreign countries. The theme emphases for the encouragement of small entrepreneurs towards exporting to foreign countries to fetch confidence on better future and revenue to reach the ultimate goal of creating a sound economy in the country. Government of India has a vision of making India a \$5 trillion economy and a global economic powerhouse by 2025. In 2019, India has become a \$2.7 trillion economy, having added one trillion US dollars in the last five years. The vision to become a 5 trillion dollar economy by 2024-25 is challenging, but it is realisable. The seminar throws light upon this not so distant optimistic goal of our government and to discuss about the export trends followed by our country in order to achieve the same. This discussion shall not only engage an active discussion on steps, measures, suggestions and techniques employed in order to achieve the economic goal but also create an awareness on the policy to the student community.
