Summary of the Activity	<p>In order to bring an understanding on the process of e-filing the income tax returns, the department of commerce organised a fortnight webinar which would help the assesseees to file their returns. The following insights were shared during the webinar:</p> <ol style="list-style-type: none"> 1. Tax Planning for Salaried Individuals - Significance of tax planning was emphasized, highlighting how it can help individuals optimize their tax liabilities and maximize their savings. Strategies such as utilizing deductions, exemptions, and allowances were discussed to minimize the taxable income. 2. Understanding Income Tax Slabs - The various income tax rates (both new and old regime) were explained, along with the applicable surcharges and cess. 3. Investment Avenues for Tax Savings - Investment options like Employee Provident Fund (EPF), Public Provident Fund (PPF), National Pension System (NPS), tax-saving Fixed Deposits, and Equity-Linked Savings Schemes (ELSS), Housing loan etc., were highlighted. These investments not only help in saving taxes but also in building wealth over time. 4. Form 16, Form 26AS & AIS - The significance of Form 16 (provided by the employer), Form 26AS and AIS (consolidated tax statement) in the tax filing process was explained. 5. Introduction to E-filing - Benefits of e-filing tax returns were highlighted, including its convenience, speed, and reduced likelihood of errors. Participants were guided through the process of registering on the income tax portal and submitting their returns online.

Deadline and Penalties - The importance of adhering to the deadlines to avoid penalties was stressed. Participants were reminded of the due dates for filing returns and making tax payments.</p> <p>8. Q&A Session - Each session concluded with a Q&A, where participants had the opportunity to ask specific questions related to their tax situations and e-filing concerns.</p> <p>Overall, the webinar provided valuable insights into tax planning strategies for salaried individuals and guided them through the process of electronic tax filing, ensuring they are well-equipped to manage their taxes and filing efficiently.</p>

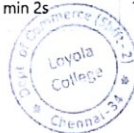

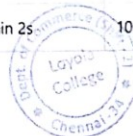

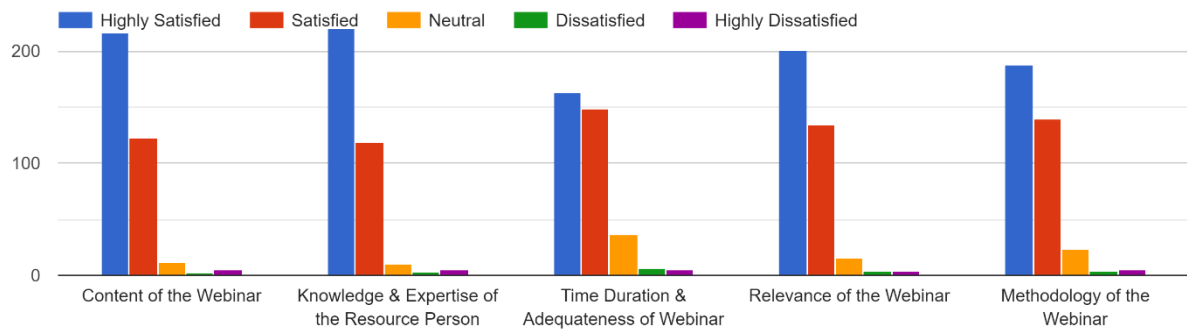
